1. APOLOGIES FOR ABSENCE

There were apologies from Cllr Jones, County Councillor Hohler and Borough Councillor Kemp.

2. DECLARATIONS OF INTEREST

There were no Declarations of Interest.

3. MINUTES

It was RESOLVED that the minutes of 5th October 2021 be approved and signed as an accurate record.

4. EXTERNAL REPORTS

a) <u>County Councillor Hohler</u> There was no report.

b) Borough Councillor Montague

- Offham is still waiting for the one-off brown lidded garden bin collection
- There will be a new Call for Sites for the Local Plan. The new calculation is that 2,500 new houses are needed for the Borough
- Finances are under even more pressure than before. There is a constant reduction in central Government Funding, but Councils are not allowed to raise council tax beyond a nominal 5%. There will be some difficult decisions ahead, about raising funds or reducing costs

c) Police

There was no report.

5. PLANNING

a) New applications

 TM/21/02386/FL - 3 Bramble Hall Cottages, Comp Lane - Demolition of single storey rear and side additions and garage. Erection of single storey rear extension and two storey side extension

It was RESOLVED that there were NO OBJECTIONS.

ii. TM/21/02439/OA - Barfield House, Teston Road - Erection of 7 no. dwellings and new access to highway

There was a discussion and it was RESOLVED to OBJECT to the application:

- The 7 houses take up virtually the same amount of land as the application for 14 houses which was refused
- The situation is exactly the same situation as for the last application
- · The land is on Green Belt
- There is already permission for 7 houses within the boundaries of the village. The application says that it is for a small development (under 10) and argues it is within the curtilage of Barfield Farm

iii. TM/21/02570/LB - Orchard Place Cottage, Comp Lane - Listed Building Application: Removal of modern dry lining and plasterboard and modern skirtings in order to be able to fully specify the repairs necessary to the timber frame It was RESOLVED that there were NO OBJECTIONS

b) Approvals

- TM/21/02216/TNCA Hodges Place, Church Road Fell two trees, Walnut and Whitebeam, which are dead or dying
- ii. **TM/21/01741/LB 2 Swan Cottages, The Green -** Listed Building Application: Replacement of two first floor and one ground floor windows to principal elevation and first floor window to side elevation. Replace the "Georgian style" part glazed door to the garden with a similar and appropriate hard wood part glazed external door
- iii. TM/21/02084/TNCA Postern House, Teston Road Works to a Laburnum Remove lowest overhanging stem, Cypress and Magnolia reduce face in parking area, 180 degree face reduction by 20% and to fell 2x Cypress and a Yew tree.
- iv. **TM/21/01792/RD Blaise Farm, Tower Hill -** Details of planning condition 2 (materials) submitted pursuant to planning permission TM/15/01599/FL (first floor extension, single storey extension and alterations to external appearance).
- v. TM/21/01825/FL 2 Quarry View Cottages, Comp Lane Two storey side extension, single storey rear extension and detached garage

d) Any other planning matters

- TM/21/01539/FL White Ladies, Teston Road- Demolition of the existing building and construction of 3x detached residential dwellings with associated access arrangements. APPLICATION WITHDRAWN
- ii. TM/21/02262/FL Amberley Lodge, Teston Road Demolition of existing porch and conservatory and replacing the conservatory with a new garden room (NO OBJECTIONS)
- iii. TM/21/02347/FL Land South West Of Fre Mel Farm, Comp Lane Extension to existing workshop (NO OBJECTIONS)
- iv. County Councillor Hohler has provided details of a solar park proposal just outside of the Offham Boundary at Kings Hill, near the entrance to Blaise Farm Quarry. The land is on Green Belt.

6. MATTERS ARISING

a) To consider Maintenance Contract 2022
 Cllr Unter will update the maintenance contract for the Parish Council to consider next month and send out for tender.

- b) To consider response to LGBCE Electoral Review Consultation (03.12.21) The Parish Council will not respond to the consultation.
- To discuss ownership of Village Hall and First Registration
 Following information provided, Nat West have been asked if they hold any original deeds.
- d) To note Footpath MR286 diversion The diversion for the Quarry was noted, and it was reported a permissive path has also been provided.
- e) <u>To consider temporary Verge Signs on Teston Road "no litter" and "no speeding"</u> This is included in the Highways Improvement Plan.
- f) To consider maintenance of Village Sign
 Cllr Benton estimated the cost of repainting the sign at about £400. Cllrs Marchant and Bailey will inspect the post and provide a cost for repairs when it is taken down.

7. OPEN FORUM - Public Participation Session

There were no members of public present and no questions submitted in advance.

8. PARISH COUNCILLOR REPORTS:

a) Blaise Farm

i. Quarry

Mechanical noises heard in the Village - Gallagher report they have been over burden stripping at the surface. This has finished for the present and they will not be stripping over burden until next Spring.

Comments about the size of some recent blasts - Gallagher report that these are all loaded according to the planning permission limits and the variation in perception is due to the geographical position and direction of the blast. There is blast monitoring from Gallagher's own equipment, independent monitoring by outside consultants and KCC monitoring. All of this information is available on the KCC website.

- ii. IVC Waste Management There was nothing to report.
- iii. AD Plant
 There was nothing to report.

b) Offham Landfill Site (BJ)

The fencing around the path from Teston Road to Hayes Lane has been repaired. There are no updates from KCC about the Solar Park application.

c) Queens Jubilee Street Party

It was agreed that the party be held on Sunday 5th June 2022. Cllr Benton reported that the Village Hall have kindly agreed the Hall can be used for the day free of charge. The cricket club have approved use of the cricket ground and offered use of the bar. Councillors approved the use of Cosgrave Field. Councillors considered and approved provisional plans for the event:

- Crown competition for children in the Village Hall
- · Photographic competition for adults to be used for calendars
- · Children's Street Party in Church Road
- · Adults and Childrens' games on the cricket field
- · Raffle and prizes for the games
- · Blessing from the Vicar
- BBQ or Picnic
- Band in the evening, either in Cosgrave Field, The Village Green or the pub
- Permission for a road closure for Church Road will be applied for from TMBC
- Betts Farm will be notified about the road closure.

Cllr Benton was thanked for her hard work making arrangements and obtaining information. This is a Parish Council event and Councillors will all be involved in helping plan and run it and raise funds.

d) Offham Village Hall

Cllr Taylor reported on the recent meeting of the Offham Village Hall Committee who have worked very hard fund raising at the Steam Rally and Cinema. They have plans to resurface the car park, create a recess for the Wheelie Bins, work to the sewer to stop the drains blocking up and to provide wi-fi in the Hall. The Committee have unfortunately been affected by illness and injury. A plaque was recently unveiled for Martyn Begbey who did so much for the Village Hall and was instrumental in arranging the new roof.

e) Wellbeing

Cllr Benton is working a lot on wellbeing. Money from the recently disbanded Offham Community Network is being shared between the Offham Lunch Club and The Mens Shed. The Mens Shed is to promote friendship and linking up among male residents, with meetings in the pub. Tea, coffee and cakes will be provided. Cllr Scullion agreed to organise and run The Mens Shed and other Cllrs will attend. Consideration will be given as to how to invite residents who would benefit.
